



266.45 To consider and approve the proposal of engaging companies practicing Engineering / Technology and reputed Universities to offer online / hybrid courses in UG / PG curriculum in addition to SWAYAM-NPTEL platform

Prof Ranjani Parthasarthi had expressed the following

- 1. Allowing the option of offering paid online courses by private companies (or edutech firms) as a substitute for electives which are in the curriculum is, in practice, likely to lead to colleges (partnering with such companies) and cutting down on qualified faculty, thereby forcing the students to opt for these courses only. Hence this option of engaging private companies for paid courses should not be brought into the regulation.
- 2. No fee should be collected over and above the regular fee (even if it is nominal), as it is part of the curriculum.
- 3. The only sustainable option for the education ecosystem is to train the faculty for such skill-based courses which should be taken up on an immediate basis.

Vice Chancellor stated that students should not be deprived of opportunity towards enhancing their skillsets and further highlighted the following recommendations of high level committee with respect to the Agenda:

- 1. Institutes can use this online / hybrid courses as an additional option only and cannot be made mandatory for any student.
- 2. Institutes must offer elective courses in the curriculum as usual in the regular classes by physical mode and students are to be allowed to choose online courses, if they desire
- 3. Moreover the Course content, Course Plan, Student attendance monitoring mechanisms/Content delivery standards qualifications for the onlineteacher, modalities for implementation as well as Student evaluation norms, are to be decided and approved by the Academic Council

- 4. <u>No MoA</u> is required for the Online Courses offered by SWAYAM NPTEL, as it is a programme<u>offered</u> by Government of India and is also free of cost.
- 5. However with <u>paid platforms</u>, <u>MoA is to be made</u> as per university norms before permitting the students to opt online courses.
- 6. The <u>modalities for evaluation and accounting of credits</u> for curricular requirements are to be <u>evolved and approved by the Academic Council.</u>
- 7. A nominal fee <u>as approved by the University</u> shall be collected from the student over and above the regular fee.
