CIRCULAR

- Sub: Anna University - COVID-19 - Extension of State-wide lockdown till 31.08.2020 – Issued – Reg.

In the Government Order cited in Ref (1), the Government of Tamil Nadu (GoTN) had announced that the curfew orders which prevailed before 19.06.2020 in the jurisdictions of Greater Chennai Police and some areas in Chengalpattu, Kancheepuram and Thiruvallur Districts, with certain restrictions and relaxations were extended from 06.07.2020 till 31.07.2020.

In the reference 2<sup>nd</sup> cited, the Government had announced that the curfew orders which prevailed before 24.06.2020 in Madurai Corporation limits and specified areas in Madurai District till 12.07.2020 were extended for further two more days till 14.07.2020. Further the activities that could be permitted from 15.07.2020 till 31.07.2020 with certain restrictions and relaxations ordered by Government.

Now, in the reference 3<sup>rd</sup> cited, the Government of Tamil Nadu (GoTN) have announced to extend the State-wide lockdown from 01.08.2020 to 31.08.2020 in all the areas throughout the State, with the existing restrictions and following further guidelines and relaxations ordered by Government.

Accordingly, the activities carried out till 31.07.2020 i.e. the Offices to function with half the work force in a system of six-day working week will continue upto 31.08.2020. Hence, the University Campuses, Offices and Departments of Engineering Colleges will resume activities from 01.08.2020 to 31.08.2020 with restrictions and relaxations as ordered by Government.

Hence, the Deans of the Campuses, Dean i/c of Regional Campuses and Constituent Colleges, the Principals of affiliated engineering colleges of Anna University are directed to **adhere scrupulously to the guidelines, preventive measures and regulations** as issued by Government of Tamil Nadu from time to time during COVID-19.
