5. TEC, Anna University may at its discretion – extend this deadline for the submission of Eol by amending the Eol documents, in which case all rights and obligations of TEC, Anna University and bidders previously subject to the deadline will thereafter be subjected to the deadline as extended.

6. To assist in the examination, evaluation and comparison of EoI, TEC, Anna University at its discretion can ask the bidder for the clarification of its EoI. The request for clarification and the response shall be in writing.
7. Bidders may be called for making a presentation before the Technology Transfer Committee.

Terms And Conditions For Bidding:

- a) Company should be registered in India
- b) Company has to bid a upfront payment upon signing the agreement and Royalty payment of in % on the sale value of the commercialized system.
- c) Company have to commercialize within 2 years of licensing. Otherwise the licence will be liable to cancel.
- d) The ToT agreement shall be valid for ten years and be subjected to further renewal upon mutual agreed terms and conditions.
