Guidelines

- ➤ Faculty member(s) who are regular employees of the University / Scientist(s) employed in projects / PPP Centers and who have carried out the work leading to Innovation and subsequent grant of patent may apply for Innovation award.
- ➤ The innovation should result in either a prototype or commercialization which should have been made through an MOU / MOA.
- Applicant(s) can be a single member or a team of members.
- The period of claim for the award will be from 01.04.2018 to 30.09.2024
- ➤ The work should have been carried out at the University with or without the support from industry or sponsoring agency.
- ➤ In case of multiple products / processes, applicant(s) can file more than one nomination only if the applicant can establish / prove that there is a significant difference between / among the other products / processes etc.
- ➤ The details of the Innovation (either the process / technology / product alongwith the granted patent details and the lead role played by the applicant for Innovation through Interdisciplinary / inter institutional projects, proof of attempts for commercialization (MOU / MOA) if any, to be highlighted with evidence.

- ➤ Faculty member(s) who are regular employees of the University / Scientist(s) employed in projects / PPP Centers and who have carried out the translational research leading to Technology Transfer are eligible to apply for Technology Transfer award.
- > Applicant(s) can be a single member or a team of members.
- ➤ The period of claim for the award will be from 01.04.2018 to 30.09.2024
- ➤ The work should have been carried out at the University with or without the support from industry or sponsoring agency. In case of distinct multiple products / processes, applicant(s) can file more than one nomination only if the applicant can establish / prove that there is a significant difference between the other products / processes.
- The Technology Transfer should have been made to industry / community and documented / certified by the industry or user community.
- > The details of technology transferred to the industries / firms etc, revenue generated (one time / recurring), validity and the lead role played by the applicant for Technology Transfer through Interdisciplinary / inter institutional projects are to be furnished.
- Applicant will be requested to present the technology transfer that has been made to industry before Screening / Selection Committee
- ➤ Information about Patent(s) filed / granted for the Technology to be presented with evidence.

Guidelines

- Distinguished Researcher award will be given for those who have proven their research capabilities by undertaking intensive research during the period 01.04.2018 to 30.09.2024
- Nominations can be made based on self-nomination or by a Professor of Anna University having more than ten years of experience. The nominations should be sent to Director CSRC through proper channel (Head of the Department / Director of the Centre or Institute / HOD and Dean of Regional Centres / Constituent colleges).
- ➤ The faculty members who were presented with the Distinguished Researcher award earlier (previously called Active Researcher Award) are not eligible for the nomination again in the same category.
- Only projects sanctioned to / received by the individual capacity as faculty members, based on the proposal submitted or request received should be included in the list of projects. Projects like FIST, DRS, RUSA, UGC-SAP etc. which were sanctioned to the Departments / Centres / University in which the faculty members were appointed as Coordinators need not be included.

- ➤ The faculty members who were presented with the award earlier are not eligible for the nomination again in the same category.

- ➤ The faculty members who have already obtained Research Excellence award in one category may also apply for next higher category but after two years. However, only one application against one category can be made at a time.
- > Impact factor is to be calculated on or after 30.09.2024.
- ➤ The applicant should either be the First author or Corresponding author or both or one among the equally contributed authors which should be explicitly stated in the journal paper itself.
- Provide the list of publications with Impact factor in the format "Title of the paper, Authors name, Affiliation, Name of the Journal, Vol.no, Year, Page number" (as per format given below) with the first page reprint of research publication highlighting the title, author name, Affiliation, abstract and publisher details.
- ➤ The hardcopy of the application duly signed by the HOD / Director / Dean may be sent to the Director, Centre for Sponsored Research and Consultancy, Anna University, Chennai or scanned copy of the application may be sent to the e-mail directorctdt@gmail.com. The soft copy of the list of publications with Impact factor may also be sent to directorctdt@gmail.com.
