- 1. Price: Printed and **BOUND PRICE LIST** for the year 2022-2023 (Both Hard and Soft copy) duly signed with seal by the authorised signatory must accompany the tender which shall be valid for entire year.
- 2. <u>Financial Status</u>: The average Annual Turn over of the vendor should not be less than Rs.25.00 lakhs in the last three consecutive years for the supply of above items.
- 3. <u>Periodicity/Duration of the Rate Contract</u>: The Rate Contract is initially for the financial year 2022-23 and will exist until the next new rate contract is finalised.
- 4. Where the Rate Contract for the supply of imported items (subject to custom duty and foreign exchange variations) and/or locally manufactured (subject to GST etc.), the price should be specifically stated along with the selling rates of foreign exchange element taken into account in the calculation of the price list of the imported items.
- 5. GST: The rate of GST should be mentioned specifically for each item separately.
- 6. DSIR Certificate (Concessional GST) will be issued by the Anna University for the items purchased for Research oriented purpose.
