DISTINGUISHED RESEARCHER AWARD

Contributions towards the sponsored research activities of the University during the period April 2016 - March 2021.

ACTIVE CONSULTANT AWARD

Active participation in the consultancy works and generating revenue for the University during the period April 2016 - March 2021.

RESEARCH EXCELLENCE AWARD

Research publications with Anna University Affiliation in Scopus Indexed Journals of more than 175 publications in category 1 & 100 publications in category 2.

Who can apply?

- > Applicant should be a Regular Faculty member of Anna University.
- > An applicant can be nominated under more than one category.
- > Separate application should be sent for each nomination.

Guidelines for Distinguished Researcher Award 2022

1.	Prize money	Rs. 25,000/- cash prize along with a citation and a memento.
4.	Eligibility & norms	 Distinguished Researcher award will be given for those who have proven their research capabilities by undertaking more research during the period April 2016 - March 2021. Nominations can be made based on self-nomination or by a professor of Anna University having more than ten years of experience. The nominations should be sent to Director CSRC through proper channel (Head of the Department / Director of the Centre or Institute / HOD and Dean of Regional offices / Constituent colleges). All permanent faculty members, excepting those who received Active Researcher Award earlier and who have completed the sponsored research projects in our University though CSRC during the last five years, till 31st March 2021, are eligible for nomination. Only projects sanctioned / received in the individual capacity as faculty members, based on the proposal submitted or request received should be included in the list of projects. Projects like FIST, DRS etc. which were sanctioned to the Departments / Centres in which the faculty members were appointed as coordinators need not be included.
5	Application submission	The application should be filled through CSRC website and the online generated hardcopy of the application alongwith the self-assessment sheet routed through HOD / Director should be sent to the Director, CSRC on or before 17 th September 2022.
